**Rainbow Farms (Pty) Ltd | Eskom Proposed Isundu 765/400 KV Sub-Station and Turn-in Transmission Lines**

We refer to our objection dated the 09 June 2015 to the above proposed Sub-Station and Turn-in Transmission Lines. In that submission we noted that according to our records we had no knowledge of the re-instated application and approval for the transmission line corridor under EIA 12/12/20/1397/1 and 3 and approval of 11 June 2012. We urgently request copies of the environmental authorisation and the notification to interested and affected Parties of its approval, and copies of any communication and correspondence that was had with Rainbow relevant to this project. Your urgent dispatch of these documents is appreciated.

If you are not in possession of all the necessary documentation, kindly provide us details of the representative of your client at the time and the consultants who managed this process.

On receipt of this information and on further investigation on behalf of Rainbow, Rainbow may be compelled to take whatever steps necessary to rectify this situation if it resulted from procedural irregularities. This will have a significant effect on the process you are engaged in in the authorisation of the sub-station, which is reliant upon the corridor. Accordingly, the sooner the detail of the approval of the transmission line corridor is provided to us the better it will be for all parties concerned.
