**AVAILABILITY OF THE DRAFT ENVIRONMENTAL IMPACT ASSESSMENT REPORT FOR PUBLIC  
COMMENT**

Scoping and assessment of impacts, as part of the Environmental Impact Assessment (EIA) for the above project, has been underway since July 2016. A Draft Environmental Impact Assessment Report (DEIAR) has been prepared in terms of the current Environmental Impact Assessment Regulations, 2014, published in Government Notices R 982, 983, 984 and 985 of 4 December 2014 under Section 24(5) read with Sections 24, 24D and 44 of the National Environmental Management Act, 1998 (Act No. 107 of 1998) (as amended).

Based on the current regulations, the Environmental Assessment Practitioner (EAP) must complete Scoping and the Impact Assessment within 300 days of acceptance of the Application for Authorisation by the National Department of Environmental Affairs (DEA). It is also envisaged that a Water Use Licence will be required from the Department of Water and Sanitation in terms of Chapter 4 of the National Water Act, 1998 (Act No 36 of 1998), in particular, Section 40(4). The DEIAR is now available for review and comment by members of the public and commenting authorities.
