We received your query regarding the relocation of the hydrocarbon pipeline – herewith some feedback.

Attached drawing shows the concept of the relocation of the 2 pipelines. You will see that the proposal (in green) was to relocate a section of the 2 pipelines to just outside the new road reserve, to make space for the new Directional ramp F.

SANRAL / Transnet is appointing a specialist firm to manage the relocation of the hydrocarbon pipelines. This detail design process may result in some changes to the concept.
