Only the background information document and project announcement have been undertaken to date, with a public open day where people could see detailed engineering drawings if they wanted to. BA Reports for public review are still in draft.

The attached figure is not very detailed but widening in the vicinity of Giba will be contained within the median and existing road reserve. A temporary haul road will be constructed to get underneath the uMhlatuzana viaduct, from the southern side (follows the old track used when originally constructed). Lyle Ground recommended the route. I am sure the engineers can make available more detailed diagrams to affected land owners.
