Hi Duncan,

Access to the proposed pump station site is possible via Cycad Drive and the Casa Benri entrance road to the horse camp (see attached image file). It is likely that the track in the horse camp will be overgrown and that some pruning of scrub will be necessary to a vehicle and trailer to the site you have pinpointed. On the other hand the suggested route will obviate the need to travel through operational areas and the admin that that entails. Please note that the proposed pump station site lies within our biodiversity offset and we would appreciate if the work could be undertaken with minimal disturbance to vegetation and soils.

It may also be worth noting that one of the residents of Waterbessie Street is proposing to sink a borehole for potable water in close proximity to the indicated pump station site.
