Hope you are well. I received your contact details from Vishali Luchai.

SANRAL is intending to have a report ready for public review in a couple of months' time, for Basic Assessment 2, the N3 Upgrade between Paradise Valley and Key Ridge. The public review period is 30 days.

Aside from lodging the documents at the Westville and Pinetown Public Libraries for viewing, I was wondering if there is an additional suitable venue in your area, given the impact the project has in particular, around Richmond Road.

Do you think the Ashley Sports Club is willing to hold a report where interested parties could come in and view it? It would have to stay at the venue, i.e. not for personal borrowing, and we ask that those who view it fill in a viewing register and, if desired, a comment sheet. We would then collect the material at the end of the public review period. So, it will require a limited amount of admin/management from whoever hosts the documents – preferably a receptionist who is around all day and can direct the people where to find it, etc.
