Notice is hereby given in terms of the amended EIA Regulations (2017) published under the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended, of the availability of the Draft Basic Assessment Report for the above-mentioned project.

The South African National Roads Agency SOC Limited (SANRAL) is proposing capacity upgrades to the N2 and N3 between Durban and Pietermaritzburg, to accommodate future traffic growth, increase mobility and improve road safety.

The Draft Basic Assessment Report (BAR) and Environmental Management Programme (EMPr) for **Basic Assessment 2** deals with the proposed capacity upgrades to the N3 from Paradise Valley to Key Ridge (near Assagay interchange).

The Draft BAR and EMPr for **Basic Assessment 2** will be made available for public review and comment during the statutory 30-day commenting period between **11 February 2020 – 11 March 2020** (inclusive), at the following public Venues:
